

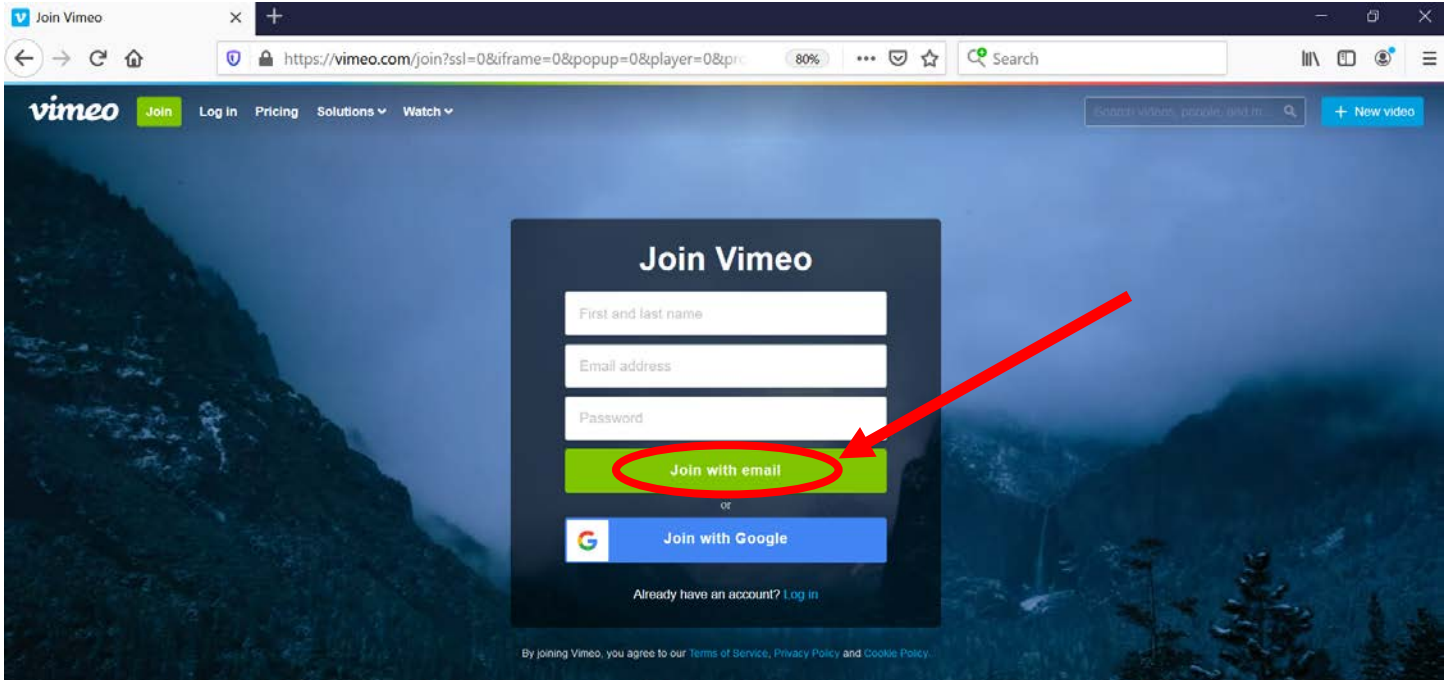

**Step 2** – Sign in if you already have a Vimeo account, or click on the Join option highlighted below to create an account.

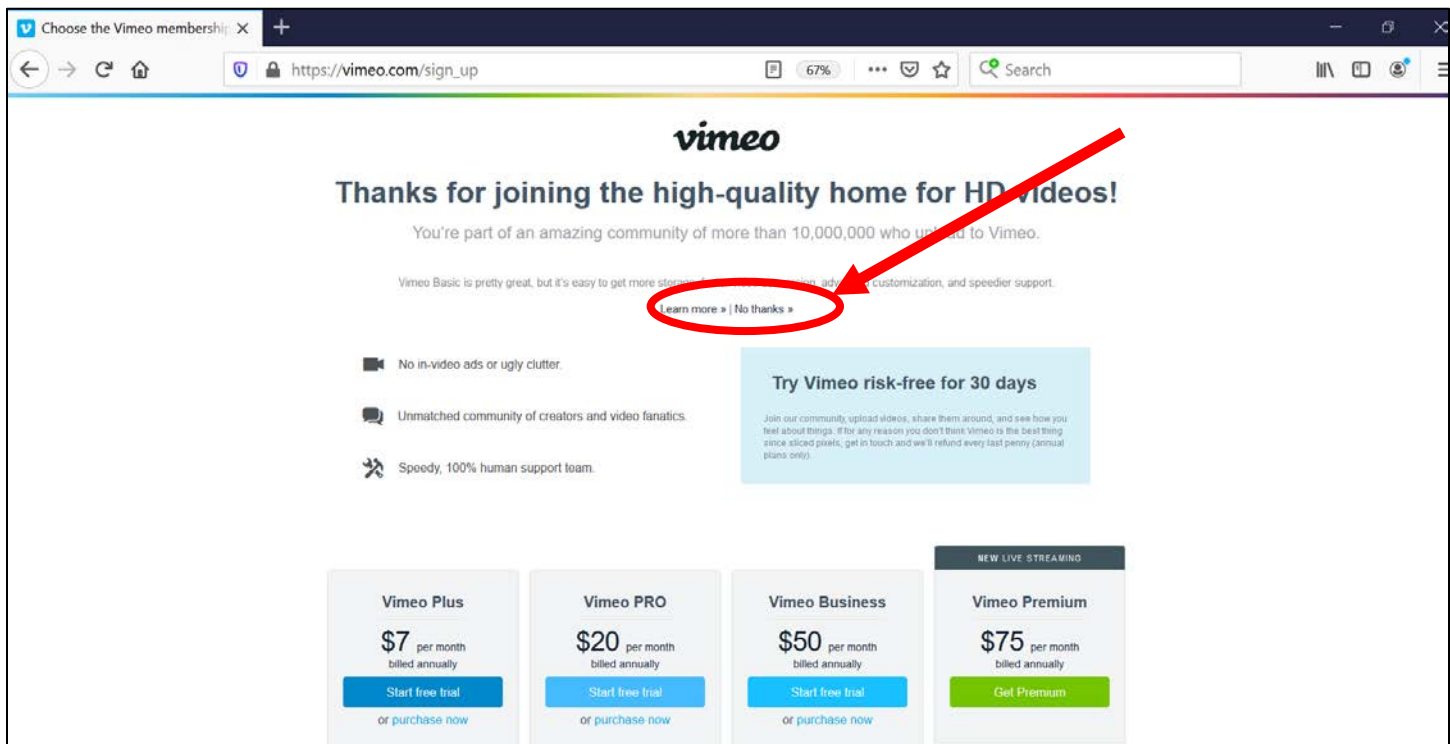
